These vouchers are to assist non-elderly persons with disabilities and their families.

Who Can Apply

- Must live **in the area** (Holly Hill, FL to Oak Hill, FL) for **6 months or more**,
- Have a family member that is **18 – 61 & has a disability**.

How to Apply

- Contact one of our MSV Partners for an appointment to apply,
- Gather your documents (Photo ID(s), Birth Certificate(s), Social Security card(s), proof of income, proof of residence, bank statements,
- Complete application with MSV Partner at appointment.
